Tickets - \$30 per person (*EVERYONE needs a ticket... adults & children of all ages*). The same tickets retail for **\$55-\$65 each on the Gateway website**. Tickets will be mailed to the address on the form the 2nd half of June! Also included for FREE is a ticket to the fan walk experience if your travel plans allow... see next section.

Fan Walk Experience - The fan walk will be open during both practices and qualifying... it will close around 5 PM (roughly around when qualifying ends). The fan walk is basically a grassy fenced in area that is in between pit road and the garage area. You can expect to see teams working on the cars if you are in the area during practice and you can expect to see the pit crew setting up their pit stalls if you are in the area during qualifying. If your travel plans are for you to arrive just in time for the race please do not request for the fan walk tickets.

Buses - If you are interested in busing from Springfield to Gateway please select "YES" below. This will allow me to see how many people would be interested and I can work on pricing and scheduling. From there I can contact those interested and relay the information. Like last year I'll work on keeping it affordable. If enough people are not interested I will let you know as well.
